O R D E R

Heard Sh. Siddharth Luthra, learned Amicus Curiae and the learned counsels appearing for the respective parties. It is very unfortunate that despite sufficient time being given, many of the parties have not complied with the directions issued on the last occasion by duly filing their respective compliance affidavits.

Learned counsel appearing for the non-complying parties made a fervent plea that due compliance will be made by the next date of hearing.

Considering the said submissions, we are deferring from passing any adverse orders. We make it clear that if the due compliance is not reported by the next date of hearing, the consequence will follow.

We are inclined to give further time up to 30.06.2024 to

all the non-complying parties to file their respective affidavits of compliance. While doing so, they should take into consideration the non-compliance as indicated by the learned Amicus. We also facilitate the High Courts, the States, the Union of India and the Union Territories to have a discussion with the learned Amicus through video conferencing. A link will be sent to them in order to facilitate a discussion between 5.30 PM to 6.30 PM on 15th, 18th, and the 19th of July, 2024 for the purpose of due compliance, if not already made, as submitted by the learned Amicus.

We also make it clear that communication must strictly be made through the E-mail ID that has been created i.e. complianceinartil@gmail.com, which has already been duly intimated to the States, High Courts, the Union of India, the CBI and NALSA for the aforesaid purpose of interacting with the learned Amicus.
